## GENERAL INFORMATION

PROMOTE is an activator adjuvant specifically formulated to enhance the performance of a wide range of both systemic and contact fungicides and their tank mixes.

## DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. The applicator or crops advisor must have experience with the pesticide combination, including PROMOTE, or must have conducted a phytotoxicity test prior to use. Do not use this product in a manner inconsistent with labeling. PROMOTE increases the activity of many pesticides. Therefore, care must be taken when treating sensitive crops during periods of drought stress, high temperatures or high humidity.

## USE RATES

**Ground Application:** 0.125% v/v (1 pint per 100 gal. of spray solution).

**Aerial Application:** 0.25% v/v (1 quart per 100 gal. of spray solution) or a minimum of 1.5 ounces per acre. Do not exceed 3 ounces per acre.

## MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

## STORAGE AND DISPOSAL

This product does not require heated storage. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
