GENERAL INFORMATION

AirForce combines the benefits of highly refined modified soybean oil with an advanced nonionic organosilicone surfactant emulsifier. This adjuvant blend deposits the pesticide on the plant leaves and into the crop canopy in a form that continues to improve the surface activity of the oil portion of the droplet, even after the water has evaporated.

AirForce enhances herbicide, fungicide and insecticide applications by:

- Offering excellent penetration of cuticular wax on the leaf surface
- Increasing spray deposit into the crop canopy
- Keeping the pesticide in a liquid form longer on the leaf surface
- Providing superior extended droplet spreading with three surfactant systems that have a positive effect in the spreading of both the water phase and the oil phase of a droplet
- Increasing crop safety by eliminating "hot-spots" on the leaf

DIRECTIONS FOR USE

MIXING INSTRUCTIONS: SHAKE WELL BEFORE USING. Always add **AirForce**® last to the spray mix and continue agitation or follow specific tank filling information on the pesticide label. If excessive foaming develops, the addition of a defoaming agent is recommended with decreased agitation.

USE RATES

HERBICIDES

Ground: 2-6 pints per 100 gallons of water
Air: 6-10 pints per 100 gallons of water

INSECTICIDES, FUNGICIDES

Ground: 3-6 pints / 100 gallons of water
Air: 1-3 GPA of spray solution per acre or 3 fl oz **AirForce** per acre
 Over 3 GPA spray solution per acre or 5 fl oz **AirForce** per acre

STORAGE AND DISPOSAL

STORAGE: Store in a cool, dry place. Store tightly closed in the original container. Do not add anything else to the container.

DISPOSAL: When container is empty, triple rinse the container and pour rinsate into the spray tank. The empty container must be disposed of or recycled according to all local, state and federal laws and regulations. DO NOT REUSE THE CONTAINER.

FIRST AID
