GENERAL INFORMATION

ARRAY is a unique micro homogenized, easy to use formulation of ammonium salts and specially designed polymers which acts as a deposition aid, foliar retention agent and canopy penetrating agent.

ARRAY improves spray deposition, retention and canopy penetration.

ARRAY also improves pesticide performance by reducing hard water antagonism in the spray tank.

ARRAY is formulated for use with herbicides, insecticides and fungicides, unless specifically prohibited by the pesticide label. Users should always check for tank mix compatibility with specific pesticides.

USE RATES

Ground and Aerial Applications
9 lbs. of ARRAY per 100 gallons of spray solution.

MIXING INSTRUCTIONS

IMPORTANT - Add ARRAY to the spray tank first before adding any other tank mix product, unless the tank mix pesticide(s) or additives direct otherwise.

Mixing Order

1. Fill tank 1/2 full of water and begin agitation.
2. Slowly add the required amount of ARRAY and allow the product to completely dissolve.
3. Continue filling spray tank with water and add the tank mix components as directed on the pesticide label(s).

STORAGE & DISPOSAL
