FIRST AID

GENERAL INFORMATION

Border AQ is a concentrated liquid premix of drift reduction polymers, retention aids and surfactant. Border AQ enhances pesticide performance on a wider range of weed species by improving spray droplet retention, adhesion and coverage on targeted leaf surfaces. Additionally, Border AQ reduces drift by mitigating the physical off-target movement of spray droplets.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using Border AQ, the applicator or crops advisor must have experience with the pesticide

combination, including Border AQ, or must have conducted a phytotoxicity test.

USE RATES

0.375–0.5% v/v (3–4 pints) of Border AQ per 100 gallons of spray solution.

4 pints of Border AQ provides the equivalent of 1.2 pounds of ammonium sulfate.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

This product does not require heated storage. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
