FIRST AID

GENERAL INFORMATION

Border Max is formulated to improve herbicide performance potential by reducing spray particle bounce, improving spray droplet retention and adhesion to leaf surfaces while reducing physical drift. Border Max further improves spray solution quality by reducing antagonism of certain metal ions in the spray solution while providing ammonium ions for improved uptake and transport of certain herbicides.

DIRECTIONS FOR USE

The addition of adjuvants to some herbicide and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using Border MAX, the applicator or crops advisor must have experience with the herbicide

combination, including Border MAX, or must have conducted a phytotoxicity test.

USE RATES

1–1.25% v/v (1–1.25 gallons) of Border MAX per 100 gallons of spray solution.

Border MAX provides 4.25 lbs. of dry ammonium sulfate per 1.25 gallons.

MIXING

In the absence of specific mixing instructions found on the herbicide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension and microencapsulated (LC, SC, ME).
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS).
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect product from freezing. *If product freezes, warm to room temperature and agitate before use.* Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
