### DIRECTIONS FOR USE

Read and follow all accompanying tank mix product labels prior to application. PHT Crop Oil Concentrate may be applied by ground, aerial or CDA equipment. Consult the accompanying pesticide label regarding specific adjuvant use recommendations. Do not add PHT Crop Oil Concentrate at a rate to exceed 5% of the finished spray volume. For tank mix compatibility concerns, conduct a jar test of the proposed mixture to ensure compatibility of all components. Mix components at the same ratio as the proposed tank mix.

Not for use on aquatic sites.

### USE RATES

**Air:** 1 to 3 pints in 2 to 15 gallons of water

**Ground:** 1 to 8 pints in 10 to 100 gallons of water

**NOTE:** The above use recommendations are considered to be adequate for most uses. Some pesticides, however, may require higher rates for optimum effect. Follow the pesticide label directions when this occurs.

### GENERAL INFORMATION

PHT Crop Oil Concentrate Oil adjuvant is a high performance, multi component formula designed for use with a broad range of pesticides where an oil concentrate adjuvant is recommended.

PHT Crop Oil Concentrate is fertilizer compatible and can be tank mixed with a wide range of fertilizer and micronutrient products.

Use PHT Crop Oil Concentrate with pesticides and/or fertilizer products to improve spray application by modifying the wetting and deposition characteristics of the spray solution resulting in a more even and uniform spray deposit.

PHT Crop Oil Concentrate increases the effectiveness of the spray mixture therefore it is recommended that a small test area be treated prior to conducting large scale applications.

### MIXING

1. Fill spray tank 1/2 with water;
2. Add the desired amount of herbicide and/or fertilizer;
3. Continue filling with water;
4. Lastly, add PHT Crop Oil Concentrate;
5. Continue agitation.
