GENERAL INFORMATION

ANTERO-EA is composed of surface active agents and organic polymers that help reduce surface tension and aid in pesticide retention on plants. ANTERO-EA can be used with a wide range of agricultural chemicals, especially wettable powders or dry flowable formulations of fungicides and insecticides. ANTERO-EA helps agricultural chemicals adhere to the plant surface thus resisting "wash off" during wet conditions. ANTERO-EA is designed for use with agricultural fungicides, herbicides and insecticides to speed wetting, give more uniform coverage and improve adhesion between the pesticide and the plant surface. ANTERO-EA may be applied by air or ground (including backpack), and may be used in chemigation applications.

DIRECTIONS FOR USE

Care must be taken when spraying sensitive crops.

Always add ANTERO-EA as the last ingredient to the tank with agitator running. Pesticides should be well mixed before addition of ANTERO-EA.

Use caution at the higher application rates. When applying to a sensitive crop, and before making a full-scale treatment, begin by treating a small area to determine if there may be adverse effects on the crop.

Before using ANTERO-EA on stone or pome fruit, consult your Wilbur-Ellis fieldman or licensed consultant.

USE RATES

ACARICIDES, FUNGICIDES AND INSECTICIDES: Use 1/8-2 pints (2-32 fl. oz.) per 100 gallons of spray mixture.

CITRUS: When ¼ inch or larger fruit are present, use 2 fl. oz. of ANTERO-EA per 100 gallons of spray mixture; otherwise, use 1/8-2 pints (2-32 fl. oz.) of ANTERO-EA per 100 gallons of spray mixture.

HERBICIDES: Use 1-3 pints (16-48 fl. oz.) per 100 gallons of spray mixture.

OTHER USES

AQUATICS: ANTERO-EA may be used as an additive with aquatically labeled pesticides. The use rate for ANTERO-EA should follow the recommended adjuvant rate that is specified on the pesticide label.

BACKPACK OR HANDHELD SPRAYERS: Use ½-1 teaspoon per gallon of spray mixture.

For pesticides that permit use of an adjuvant at a higher rate, follow instructions on that pesticide label. HOWEVER, DO NOT ADD THIS PRODUCT AT A RATE WHICH EXCEEDS 5% OF THE FINISHED SPRAY VOLUME. Use caution at the higher use rates. When applying to a sensitive crop, first treat a small area to determine if there are any adverse effects to the crop.

STORAGE AND DISPOSAL

Do not contaminate water, food or feed by storage and disposal.

PRODUCT STORAGE: Store in a cool, well-ventilated place. Store in original container only and keep tightly closed. Store in a closed storage area and locked up.

PRODUCT DISPOSAL: Dispose of contents in accordance with all government regulations. To avoid waste, use all material in this container by application according to label directions.
