## 5. FIREFIGHTING MEASURES

---

Suitable Extinguishing media: Small fires - Dry chemical, CO<sub>2</sub>. Large fires – Foam, water spray. Water jet not recommended due to frothing.

Specific Hazards: Product will burn under fire conditions.

PPE and Precautions: Firefighters should wear NIOSH/MSHA approved self-contained breathing apparatus and full protective clothing.

## 6. ACCIDENTAL RELEASE MEASURES

In Case of Spill: Evacuate the spill area, except for cleanup personnel. Wear personal protective equipment (PPE). Control spill with adsorbent pads or booms. Recover free liquid. ## 7. HANDLING AND STORAGE

---

Handling Procedures: Avoid inhalation of vapor or mist. Avoid contact with skin and eyes. Mix thoroughly. Do not freeze. Freezing will affect the physical condition but will not damage the material. Thaw and mix before using. Ethylene oxide may collect in container head space. Provide adequate ventilation.

Storage Procedures: Keep container tightly closed in a dry and well-ventilated place. Keep away from incompatible materials to be indicated by the manufacturer. Do not freeze. Do not mix with incompatible materials.

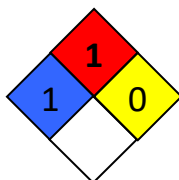
