GENERAL INFORMATION

Finan HL is a high surfactant methylated seed oil that is used at 50% the traditional use rate of ordinary methylated seed oils and crop oil concentrates. **Finan HL's** unique blend of surfactant and methylated seed oil makes it an ideal tank mix partner for enhancing the performance of a wide range of herbicide tank mixes.

For use with Enlist™ Duo: Enlist Duo may only be tank-mixed with products that have been tested and found not to adversely affect the spray drift properties of Enlist Duo. A list of those products may be found at EnlistTankmix.com.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. The applicator or crops advisor must have experience with the pesticide combination, including **Finan HL**, or must have conducted a phytotoxicity test prior to use.

USE RATES

Use 2 quarts per 100 gallons of spray solution or a minimum of 10 – 12 ounces per acre.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Protect product from freezing. *If product freezes, warm to room temperature and shake or recirculate before use.* Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. **CONTAINER DISPOSAL:** Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
