GENERAL INFORMATION

GATEWAY NG is a premier drift reduction and deposition aid technology that can be used alone or as a tank mix partner with water conditioning agents and other adjuvants to improve spray droplet placement and retention on target leaf surfaces.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using GATEWAY NG, the applicator or crops advisor must have experience with the pesticide combination, including GATEWAY NG, or must have conducted a phytotoxicity test.

FOR USE WITH PESTICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND AND RIGHTS-OF-WAY. NOT FOR AQUATIC USE.

USE RATES

0.5–1.0% v/v (4–8 pints) of GATEWAY NG per 100 gallons of spray solution.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume.

When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. GATEWAY NG and flowable formulations (F & L)
5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

STORAGE AND DISPOSAL

Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal. The Agricultural Container Recycling Council (ACRC) operates the national recycling program.
