PIM MSO ULTRA is a unique blend of methylated soy oil, emulsifiers and surfactants. Methylated seed oils, and specifically those based on soy oil, have been tested by universities and shown to improve herbicide performance under a wider range of environmental conditions when compared to crop oil concentrates and nonionic surfactants.

DIRECTIONS FOR USE

SHAKE WELL BEFORE USING

Use this product at 1.5 to 2 pints per acre with the herbicide of choice. Always read and follow the label of the herbicide to be used with this product. The 2 pints per acre rate may be required if weed populations are extreme or if plants are stressed at the time of treatment. Always add this product to the spray mix last and continue agitation or follow specific tank-filling information on the herbicide label. Do not allow water to be introduced. Always refer to the herbicide labels for additional recommendations or precautions.

STORAGE AND DISPOSAL

Protect product from freezing. If product freezes, warm to room temperature and agitate before use. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
