#### GENERAL INFORMATION

DELTA DRA is a convenient premix of drift reduction technology and water conditioning agents that protects the performance potential of dicamba-based products or tank mixes from antagonistic metal ions found in hard water and leaf tissue while further reducing drift risk. DELTA DRA is recognized as an approved DRA for most dicamba-based herbicides. Check manufacturer labels and websites for confirmation.

#### DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using DELTA DRA, the applicator or crops advisor must have experience with the pesticide combination, including DELTA DRA, or must have conducted a phytotoxicity test.

#### USE RATES

0.625% v/v (5 pints) of DELTA DRA per 100 gallons of spray solution with dicamba-based tank mixes.

0.5-0.75% v/v (2-3 quarts) of DELTA DRA per 100 gallons of spray solution with all other tank mixes.

#### MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

#### STORAGE AND DISPOSAL

**This product must be stored above 32°F (0°C). Failure to do so may cause damage.** Keep containers sealed when not in use. Store in original container only. Triple rinse (or equivalent) during mixing and loading. Recycling decontaminated containers is the best option of container disposal.
