FIRST AID

GENERAL INFORMATION – FS COC Supreme is a low-use-rate crop oil concentrate replacement adjuvant that enhances pesticide performance when compared to ordinary crop oil concentrates. This superior formulation combines the properties of a premium quality crop oil concentrate and nonionic surfactant. The result is excellent spreading/wetting characteristics as well as crop safety.

DIRECTIONS FOR USE – The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using **FS COC Supreme**, the applicator or crops advisor must have experience with the pesticide combination, including **FS COC Supreme**, or must have conducted a phytotoxicity test. Do not use this product in a manner inconsistent with labeling. **FS COC Supreme** increases the activity of many pesticides; therefore, care must be taken when treating sensitive crops during periods of drought stress, high temperatures or high humidity.

FOR USE WITH PESTICIDES REGISTERED FOR AGRICULTURAL, FORESTRY, INDUSTRIAL, MUNICIPAL, NON-CROPLAND, RIGHTS-OF-WAY AND OTHER APPROPRIATE USES. NOT FOR AQUATIC USE.

USE RATES – Apply at one-half the recommended rate of crop oil concentrate.

Use 0.375% – 0.5% v/v (3-4 pints of **FS COC Supreme** per 100 gallons of spray solution) or a minimum of 10-12 ounces per acre unless otherwise directed on the pesticide manufacturer's label.

MIXING – In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order: 1) Compatibility agent and/or antifoam, if needed. 2) AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants. 3) Dry soluble and suspension fertilizers / micronutrients. 4) Liquid drift retardants and flowable formulations (F & FL). 5) Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS). 6) Emulsifiable concentrates (E, EL or EC). 7) Solutions and soluble liquids (S or SL). 8) Liquid micronutrients and fertilizers. 9) Water conditioners and other adjuvants (**FS COC Supreme**) (COC, HSOC, MSO, NIS). 10) Finish filling to desired spray volume level and continue agitation.

STORAGE AND DISPOSAL – Protect product from freezing. If product freezes, warm to room temperature and shake or recirculate before use. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container. Triple rinse (or equivalent) after mixing and loading. Recycling decontaminated containers is the best option of container disposal.
