FIRST AID

EclipseUS SDC is formulated to reduce spray fines and increase deposition and coverage on targeted leaf surfaces.

DIRECTIONS FOR USE

The addition of adjuvants to some pesticides and/or fertilizers and their tank mixes may cause phytotoxicity to the foliage and/or fruit of desirable crops. Before using **EclipseUS SDC**, the applicator or crops advisor must have experience with the pesticide combination, including **EclipseUS SDC**, or must have conducted a phytotoxicity test.

USE RATES

For use with herbicides, insecticides and fungicides.

- 4-6 oz. per acre in 5-20 GPA applications.
- 6-8 oz. per acre in 20-40 GPA applications.
- 8-10 oz. per acre in 40-60 GPA applications.

MIXING

In the absence of specific mixing instructions found on the pesticide label, fill the spray tank with at least 50% of the desired finished carrier volume. When premixing in a mixing vessel or inductor, fill with at least 20% of the desired finished carrier volume. While the carrier is agitating, add tank mix ingredients in the following order:

1. Compatibility agent and/or antifoam, if needed
2. AMS, dry formulations (WP, DF, WDG, SP), and dry drift retardants
3. Dry soluble and suspension fertilizers / micronutrients
4. Liquid drift retardants and flowable formulations (F & FL)
5. Liquid concentrates, suspension concentrates, microencapsulated and capsule suspension (LC, SC, ME, CS)
6. Emulsifiable concentrates (E, EL or EC)
7. Solutions and soluble liquids (S or SL)
8. Liquid micronutrients and fertilizers
9. Water conditioners and other adjuvants (COC, HSOC, MSO, NIS)
10. Finish filling to desired spray volume level and continue agitation

ENVIRONMENTAL HAZARDS

Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when cleaning equipment or disposing of equipment wash waters.

STORAGE AND DISPOSAL

This product does not require heated storage. Keep containers sealed when not in use. Store in original container only. Do not reuse empty container.
